SUBMISSION INSTRUCTIONS

1. **Pre-proposals Applications are due June 3, 2024.** PNASH requires that you submit the **Pre-proposal Application by electronic mail to PNASH@uw.edu**. This Pre-proposal Application should be *brief* (3 pages - max). Describe the major aims, planned research/ project, approximate timeframe, personnel, and collaborations and the direct and indirect (**only 10% of these costs are included in the award**) dollar amount you plan on applying for. Please be sure to include appropriate contact information. Biosketches and letters of support are welcome, but not required at this point. We will use the information in the Pre-proposals Applications to provide feedback and determine eligibility to submit Pilot Project Proposal Application. Expect acknowledgment of receipt of your Pre-proposal Application within a week of your submission.
2. **Pilot Project Proposal Applications are due July 22, 2024 - by invitation only.** To submit your application, PNASH requires that you submit the **Pilot Project Proposal Application by electronic mail to PNASH@uw.edu**. This proposal should be *brief* (4 pages - max). Please be sure to include appropriate contact information. Biosketches and letters of support **are required** at this point. For University of Washington applicants, approval by Department Chair and School/College Dean for signatures of endorsement **may** be required – check with your department. However, proposals are *not* submitted through UW Office of Sponsored Programs; therefore, an eGC-1 submission is not required.
