Course Description: The objective of this course is to provide students with the principles of human factors engineering, and the research tools that are used to examine these principles. The class will showcase (through weekly journal article readings) the value of qualitative and quantitative methods for human factors research. That is, how to capture abstract thoughts, people's opinions, and trends as well as design studies to capture the impact of design changes and interventions more formally. The focus of the class is centered on human factors design principles for safety, productivity, functionality, and usability. Upon course completion, students will be able to begin fundamental research in human factors. The journal articles will cover research methods and design issues related to operator performance given functional, psychological, physiological, and environmental constraints.

Grading Policy: Students will be expected to fully participate in class discussions and activities. Grades will be based on such class participation, as well as on performance in conducting weekly assignments, midterm, paper presentations, and a final project.

Prerequisites / Corequisites: There are no prerequisites or corequisites for this class. However, an introductory class in Human Factors would be useful. Some of the concepts from the introductory class will be presented at a high level in this graduate-level course.

Midterm: There is one midterm in this class. The midterm will be take-home in the week of Nov 23.

Weekly Readings and Critiques: Students are expected to read the material before class. There is a weekly assignment that includes a write-up of the journal article that was assigned for discussion that week. You will submit a one-page critique for the assigned papers. The critiques are worth 5 pts each. Do not merely copy the abstract, introduction, or conclusion of the papers, you need to add value and insight beyond what is in the paper. A good critique:

- Describes the research problem being addressed and existing approaches (in your own words) (1 pt)
- Explains the general approach the authors used to address the problem (1 pt)
- Critically analyzes and questions the data, results, and methods used (1 pt)
- Discusses supplemental or follow-up research that might be pursued in the future (1pt)
