### **COURSE DESCRIPTION**

This course is offered during Summer and Spring quarters of the academic year and is a requirement for UW Occupational and Environmental Medicine (OEM) residents, Madigan Preventive Medicine (PM) residents, and other students enrolled in the DEOHS OEM MPH academic degree program. The course is also open to other clinically-oriented students, including but not limited to occupational and environmental health nursing students, medical fellows in other medical subspecialties, residents in internal medicine, family medicine, emergency medicine, and rehabilitation medicine, and third and fourth year medical students. The course is also open to non-clinically-oriented students, including exposure sciences students, with permission of the instructors. During the Summer 2023 quarter, this course will focus on legal/regulatory aspects including disability assessment, ADA, worksite wellness, the impaired worker, workplace violence, fitness for duty, and ethics in OEM. Session format: 20 min: key points

10 min: quiz

45+ min: applied exercise

- 1. Perform medical evaluations for work fitness and disability.
- 2. Write a physician ADA letter supporting the need for accommodations.
- 3. Discusses how individual and organizational factors in the workplace can influence health, well-being, and performance.
- 4. Recognize and appropriately refer impaired workers.

5. Participate in the design of violence prevention and response programs through simulation.

- 6. Learn to determine fitness for duty evaluations of commercial drivers and pilots.
- 7. Apply the ACOEM Code of Ethics to difficult OEM cases.

## GRADING

Grades will be determined student presentations (50% of grade), participating in class (25% of grade), and weekly board style quiz (25% of grade for completing it, but the quiz itself is not graded). The first year OEM/GPM residents and new nursing students will sign up to present key points, and the second year OEM residents and 2<sup>nd</sup> quarter nursing students will present an applied exercise or journal article.

The key points should be about 10 slides summarizing the main textbook chapter assigned for reading and should take about 20 minutes to present. The applied exercise can be a clinical case from your experience or a scenario you are likely to encounter in practice. A journal article may be presented instead of an applied case. The article or case should take about 45 minutes to present with ample time for discussion and engagement of the other students.

- We posit that assigning blame to persons in socially marginal positions is counter-productive to our practice. We can learn much about the dominant culture by looking at how it constructs the lives of those on its social margins.
- While we may question or take issue with another class member's ideology, we will not demean, devalue, or attempt to humiliate another person based on her/his experiences, value system, or construction of meaning.
- We have a professional obligation to actively challenge myths and stereotypes about our own groups and other groups so we can break down the walls that prohibit group cooperation and growth.

We are a learning community. As such, we are expected to engage with difference. Part of functioning as a learning community is to engage in dialogue in respectful ways that supports learning for all of us and that holds us accountable to each other. Our learning community asks us to trust and take risks in being vulnerable.

### Here are some guidelines that we try to use in our learning process:

- LISTEN WELL and be present to each member of our group and class.
- Assume that I might miss things others see and see things others miss.
- Raise my views in such a way that I encourage others to raise theirs.
- Inquire into others' views while inviting them to inquire into mine.
- Extend the same listening to others I would wish them to extend to me.
- Surface my feelings in such a way that I make it easier for others to surface theirs.
- Regard my views as a perspective onto the world, not the world itself.
- Beware of either-or thinking.
- Beware of my assumptions of others and their motivations.
- Test my assumptions about how and why people say or do things.
- Be authentic in my engagement with all members of our class.

## Pronouns

We share our pronouns because we strive to cultivate an inclusive environment where people of all genders feel safe and respected. We cannot assume we know someone's gender just by looking at them. So we invite everyone to share their pronouns.

# **Bias Concerns**

# Sexual Harassment
